The Falls Golf Club is not responsible for loss or theft of property brought by guests to the Golf Club.

For all packages, a non-refundable deposit of \$1,000.00 is due at the time of booking. Final guest numbers and final payment are due two weeks before the event. Deposits for photography are due based on the photographer's contract as signed by the client for the Just Say Yes & Pop-up Wedding packages.

For the ceremony only package, full payment is due at the time of booking.

A valid credit card on file is required for any damages or outstanding costs. Credit card must match client name on contract.

Where the client or their guests cause any damage to the premises or property of The Falls Golf Club or where excessive clean up is required, the client shall be responsible for the reasonable costs incurred including replacement or repair necessitated by such damage or excessive mess.

The Falls Golf Club is not responsible for loss or theft of property brought by guests to the golf club. The Falls Golf Club and the client shall each indemnify and hold the other forever harmless from, and against, any personal injury, property damage, loss, liability or claim of liability, expenses, fines and penalties including reasonable legal fees where caused by any wrongful or negligent act or omission by such party, or person acting under their direction or for whom they are legally responsible. All function guests remain legally liable to those persons they have injured or whose property they have damaged by their own actions

Guests are strictly prohibited from entering the golf course during the function. It is the responsibility of the client to ensure his/her guest adhere to all guidelines and respect the golf course and venue rules.

FOOD & BEVERAGE DETAILS

In compliance with health & liquor regulations, **no food or beverages can be brought in or taken out of the venue, with the exception of wedding cakes.** Wine or liquor bottles as guest favors are not permitted. All alcohol is supplied by The Falls Golf Club. If the Client wishes to bring their own wine, a \$20.00 corkage fee will apply to each bottle opened by The Falls Golf Club. Alcohol is strictly prohibited for persons under the age of 19. Consumption of alcoholic beverages are only allowed within the licensed areas of the venue.

Client acknowledges that if, for reasons other than breach of the Agreement by The Falls Golf Club, or pursuant to a right of cancellation contained in any other term of this Agreement, it cancels or otherwise essentially abandons its planned use of the The Falls Golf Club for its function (a "Cancellation"), The Falls Golf Club would be harmed.
